**STATUS UPDATE REGARDING THE REVLON BANKRUPTCY PROCEEDINGS  
AND REVLON’S MOTION TO ENFORCE INJUNCTION PROVISIONS**

Defendants Revlon, Inc., Revlon Consumer Products Corporation, and Revlon Group Holdings, LLC (together, “Revlon”) respectfully submit this Status Update pursuant to this Court’s April 8, 2024 minute order (Dkt. 591).

On April 4, 2024, Revlon filed an Omnibus Motion to Enforce Injunctive Provisions of the Plan and Confirmation Order (“Motion”) in the United States Bankruptcy Court for the Southern District of New York (“Bankruptcy Court”), seeking relief as against 552 Plaintiffs who (1) failed to file a timely Hair Straightening Proof of Claim form in the bankruptcy proceedings; and/or (2) failed to file their complaints in this MDL on or before the MDL filing deadline of September 14, 2023.

On April 18, 2024, four law firms filed objections to Revlon’s Motion on behalf of approximately 177 plaintiffs impacted by the Motion.<sup>1</sup> A hearing on the Motion is scheduled for May 30, 2024.
