**JUNE 25, 2024 ORDER DISMISSING CASES WITHOUT PREJUDICE FOR
ONE YEAR, CONVERTING AUTOMATICALLY TO WITH PREJUDICE IF
NOT REFILED**

For the reasons stated on the record on June 25, 2024, the Joint Status Report [670], and on the record at the hearing on July 11, 2024, the Court ruled as follows on the member cases listed below. The cases are dismissed WITHOUT prejudice, effective as of June 25, 2024. Plaintiffs will have one year from that date, until June 25, 2025 to refile their case as of right. However, Plaintiffs may only refile in federal court within this MDL and must also file complete PFS and authorizations within 10 business days of refileing. All motions pending in any of these individual member cases are denied as moot. Member cases terminated. If Plaintiffs do not refile their cases in accordance with this order by June 25, 2025, the dismissal of their cases will convert to a dismissal WITH prejudice automatically and as of right.
