## MOTION TO ESTABLISH 468B QUALIFIED SETTLEMENT FUND UNDER SEAL

Plaintiffs, clients of McSweeney Langevin ("Claimants' Counsel") hereby seek the Court's approval to establish the ML Hernia Mesh Qualified Settlement Fund (the "Fund") in accordance with Section 468B of the Internal Revenue Code, and the Treasury Regulations promulgated thereunder. Plaintiffs also seek appointment of Orion Settlement Solutions, LLC ("OSS") as Fund Administrator of the Fund. In seeking an Order from this Court pursuant to this Motion, Plaintiffs respectfully state the following:

- 1. The Fund is being established to resolve or satisfy one or more claims that have resulted or may result from injuries and damages sustained by all current and future Claimants' Counsel clients pursuing claims relating to hernia repair products ("Claimants"). See <u>Exhibit A</u> attached hereto.
- 2. The Fund will receive gross, unallocated proceeds, including attorney fees and expenses, to satisfy claims made by the Claimants.

- 3. The Fund will remain subject to continuing jurisdiction of this Court and is intended to qualify as a "Qualified Settlement Fund" as defined in *Treas. Reg. Sec. 1.468B-1*.
- 4. Orion Settlement Solutions, LLC ("OSS") possesses extensive experience administering Qualified Settlement Funds in numerous different causes of action. OSS's address is 3001 North Davis Highway, Pensacola, FL 32503. OSS submits to the jurisdiction of this Court.
- 5. Ex-Parte is suitable pursuant to Section 468B of the IRS Code and as Defendants have no standing to object, as this Fund merely provides the Claimants flexibility to plan for the most advantageous use of any settlement proceeds to which they may ultimately be entitled, and it preserves the deductibility of the settlement for the Defendant.
- 6. The Fund, by and through the Fund Administrator, shall be permitted to make payments to the Claimants, Claimants' Counsel, and any entities asserting a claim of subrogation according to the terms of any settlement agreement(s), as well as entities engaged to assist in claims administration and the management of the Fund, including but not limited to the Fund Administrator and Lien Resolution Administrator.
- 7. The Fund Administrator shall have authority to execute all necessary documents to perform the duties of the Fund Administrator, including but not limited to executing all structured settlement assignment documents and structured attorney fee documents.
- 8. The claims made by the Claimants are made on account of physical bodily injury and arise out of alleged liability in tort or violation of law.
- 9. The gross proceeds paid into the Fund are the sole property of the Fund. No Fund property shall be made available to the Claimants in any fashion, until such time as the Fund Administrator is directed to disburse funds pursuant to a proper distribution request. Until such time as funds are distributed, the Claimants shall not possess any rights to demand or receive any

portion of Fund property or to mortgage, pledge, or encumber the same in any manner. To the extent possible, this Motion shall be construed so as to prevent the Claimants from having any actual or constructive receipt of Fund property. Under relevant property laws, no Claimant shall be considered to have constructive receipt or economic benefit or cash equivalency of any property of the Fund while such property is under the control of the Fund Administrator, subject to jurisdiction of this Court and distribution subject to future events and agreements. Furthermore, under Davis v. Commissioner, T.C. Memo 1978-12, the court established that for income to be constructively received, the funds must be made available to the taxpayer without substantial limitation. While under control of the Fund Administrator, the property of the Fund is not unqualifiedly subject to the Claimants' demand or withdrawal.

10. Claimants request that no bond be required, provided that all monies received by the Fund, which include all principal and interest earned thereon, shall be deposited in a custody account held at First Bankers Trust (the "Bank"), a financial institution doing business in Quincy, IL for the benefit of and titled in the legal name of the Settlement Fund and invested in instruments/securities comprised of (a) United States Agency, Government Sponsored Enterprises or Treasury securities or obligations guaranteed as to principal and interest by the United States of America (or a mutual fund invested solely in such instruments); (b) cash equivalent securities including commercial paper rated A-1/P-1 by Standard & Poor's and Moody's, SEC registered money market funds, and collateralized money market accounts; (c) investment-grade corporate bonds rated A3/A-/A- or better with the rating being awarded by a major rating agency (Moody's, Standard & Poor's, or Fitch); (d) obligations of, or any obligations guaranteed to as principal and interest by U.S. municipalities rated A3/A-/A- or better with the rating being awarded by a major rating agency (Moody's, Standard & Poor's, or Fitch); (e) U.S. Dollar denominated securitized

products rated A3/A-/A- or better with the rating being awarded by a major rating agency (Moody's, Standard & Poor's, or Fitch) and/or (f) deposit and similar interest-bearing, or noninterest bearing accounts, and certificates of deposit subject to Federal Depository Insurance Corporation protections as available, which may be held within the custody account or at the issuer bank. The Bank shall follow the instructions of the Fund Administrator and/or its investment advisor pursuant to these terms and conditions, such that a principal preservation investment policy is implemented. Notwithstanding the foregoing, the Bank shall not be allowed to distribute any income or principal from the Settlement Fund except upon instructions of the Fund Administrator, or, if requested, upon the order of this Court upon the joint motion of the parties. The Fund Administrator retains the right to remove the Bank, and may designate a replacement bank, upon the written consent of Claimants' Counsel. In the event of such replacement, the terms and conditions of this Paragraph including, without limitation, those addressing bond requirements, investments, and distributions from the Settlement Fund-shall apply to any such replacement bank. The Fund Administrator shall not be liable for any losses as a result of investing the Deposit as outlined herein and directed by the Court. Any such losses shall not be recoverable from the parties, and the parties and their counsel shall have no responsibility for the Fund Administrator's performance. Receipt and/or investment of any Deposit shall be confirmed to Claimants' Counsel by the Fund Administrator as soon as practicable by account statement or other reasonable method.

11. The Fund Administrator shall be indemnified and held harmless by the Claimants and their attorneys from any claims made by any alleged lien holder, or other person or entity that attempts to assert a right of payment, reimbursement or garnishment against the Settlement Fund. Should the Fund Administrator be named as a party to, or threatened to be made a party to, any threatened, pending or completed action, suit or proceeding of any kind, whether civil,

administrative or arbitrative, and whether brought by or against or otherwise involving the Fund, by reason of the Fund Administrator having served in any capacity on behalf of the Settlement Fund, the Fund Administrator shall be indemnified and held harmless by the Claimants and their attorneys against reasonable expenses, costs and fees (including attorneys' fees), judgment, awards, costs, amounts paid in settlement, and liabilities of all kinds incurred by the Fund Administrator in connection with or resulting from such actual or threatened action, suit or proceeding; except to the extent that it is finally determined by this Court that the Fund Administrator was grossly negligent or acted with willful misconduct in connection with the administration of this Fund.

- Administrator from any claims, which arise from the negligence or willful misconduct of the Fund Administrator as determined by this Court. Should Claimants' Counsel be named as a party to, or threatened to be made a party to, any threatened, pending or completed action, suit or proceeding of any kind, whether civil, administrative or arbitrative, by reason of the Fund Administrator's negligence or willful misconduct, Claimants' Counsel shall be indemnified and held harmless by the Fund Administrator against reasonable expenses, costs and fees (including attorneys' fees), judgment, awards, costs, amounts paid in settlement, and liabilities of all kinds incurred by Claimants' Counsel in connection with or resulting from such actual or threatened action, suit or proceeding.
- 13. The Fund Administrator shall be authorized to distribute all attorney fees and litigation expenses to Claimants' Counsel, consistent with existing contingency fee contracts and to the extent required by law.

- 14. All taxes on the income of the Fund and expenses and costs incurred in connection with the taxation of the Fund (including, without limitation, the expenses of tax attorneys and accountants) shall be paid out of the Fund, shall be considered to be a cost of administration of the settlement, and shall be paid as instructed by the Fund Administrator.
- 15. Upon request, the Fund Administrator will prepare and deliver Fund Statements ("Statements") to Claimants' Counsel and/or this Court. The Statements shall include a statement of receipts, investment earnings, interest, and disbursements. The Fund Administrator shall provide the Statement no later than ten (10) business days following the request.
- 16. The Fund Administrator shall have the right to rely upon any affidavit, certificate, letter, notice, electronic mail or other document believed by the Fund Administrator to be genuine and sufficient, and upon any other evidence believed by the Fund Administrator, in its reasonable judgment, to be genuine and sufficient, which may be provided to the Fund Administrator by Claimants' Counsel.
- 17. Upon final distribution of all monies paid into the Fund, the Fund Administrator shall take appropriate steps to wind down the Fund and thereafter be discharged from any further responsibility with respect to the Fund.
- 18. The Fund Administrator will obtain a Federal Taxpayer Identification Number for the ML Hernia Mesh Qualified Settlement Fund.

WHEREFORE, Claimants respectfully request that the Court order the establishment of the ML Hernia Mesh Qualified Settlement Fund and appoint Orion Settlement Solutions, LLC as Fund Administrator pursuant to this Motion and Treas. Reg. Section 1.468B-1, and issue an Order in the form attached hereto. Claimants further respectfully request that this Motion and Proposed Order be filed under seal.

### ORDER GRANTING UNOPPOSED MOTION TO ESTABLISH A QUALIFIED SETTLEMENT FUND, TO APPOINT FUND ADMINISTRATOR, AND TO ISSUE RELATED RELIEF

Upon consideration of the Unopposed Motion To Establish a Qualified Settlement Fund And To Appoint Fund Administrator, ECF No. 3 (the "Motion"), submitted by McSweeney Langevin, Counsel for several hundred Plaintiffs (also referred to as "Claimants") in this action, and for good cause shown, the Court hereby **ORDERS** as follows:

- 1. The ML Hernia Mesh Qualified Settlement Fund (the "Fund") is hereby established as a Qualified Settlement Fund within the meaning of Treasury Regulation Section 1.468B-1, and shall remain subject to the continuing jurisdiction of this Court, as required by Treasury Regulation Section 1.468B-1(c)(1). Additionally, the Court finds that the QSF is a "qualified settlement fund" as defined in Section 1.468B-1(c) of the Treasury Regulations in that it satisfies each of the following requirements:
  - a. The QSF is to be established pursuant to an Order of this Court and is subject to the continuing jurisdiction of this Court;
  - b. The QSF is to be established to resolve or satisfy one or more claims that have resulted or may result from an event that has occurred and that has given rise to at least one claim asserting liabilities; and

- c. The assets of the QSF are to be segregated from other assets of Bard, the transferor of the payment to the settlement funds, and controlled by an escrow agreement.
- 2. Under the "relation back" rule provided under Section 1.468B-1(j)(2)(i) of the Treasury Regulations, the Court finds that Bard may elect to treat the QSF as coming into existence as a "qualified settlement fund" on the latter of the date the QSF meets the requirements of Paragraphs 1(b) and 1(c) of this Order or January 1 of the calendar year in which all of the requirements of Paragraph 1(b) and 1(c) of this Order are met. If such a relation-back election is made, the assets held by the QSF on such date shall be treated as having been transferred to the QSF on that date.
- 3. Orion Settlement Solutions, LLC is appointed as Fund Administrator pursuant to the terms, conditions, and restrictions of this Order, the Motion and the MSA (as defined in the Motion), and said Fund Administrator is granted the authority to conduct any and all activities necessary to administer this Fund as described in this Order, the Motion, and MSA. The Fund Administrator shall be the administrator of the Fund within the meaning of Treasury Regulation Section 1.468B-2(k)(3) and shall obtain a Federal Taxpayer Identification Number for the Fund upon the execution of this Order establishing the Fund.
  - 4. The Court approves First Bankers Trust as the Bank.
- 5. No bond is required for the Fund, and the Fund, which includes all principal and interest earned thereon, shall be deposited in an account comprised of (a) United States Agency, Government Sponsored Enterprises (GSEs) or Treasury securities or obligations (or a mutual fund invested solely in such instruments), (b) cash equivalent securities, and/or (c) bank deposits and certificates of deposit, provided all said deposits and certificates of deposit are fully insured by the FDIC. The Fund shall be held at First Bankers Trust, which is a financial institution doing

business in the State of Illinois (hereinafter "Bank"), for the benefit of and titled in the legal name of the Fund according to the terms and conditions of the MSA, and said financial institution shall be responsible for any and all investment related decisions, pursuant to these terms and conditions. Notwithstanding the foregoing, the Bank shall not be allowed to distribute any income or principal from the Fund except upon the written instructions of the Fund Administrator and upon written approval, or if requested, upon an order of this Court in accordance with, or as may be otherwise provided in, the MSA.

- 6. The Fund is authorized to enter into agreements with persons requesting the use of settlements with periodic payments.
- 7. The Fund is authorized to effect qualified assignments of any resulting structured settlement liability within the meaning of Section 130(c) of the Internal Revenue Code to the qualified assignee in compliance with all the requirements of Section 130 of the Internal Revenue Code and Rev. Proc. 93-94, 1993-2 C.B. 470.
- 8. The Fund Administrator is authorized to distribute (on behalf of Claimants) all attorney's fees and litigation expenses to counsel for Claimants, consistent with the existing contingency fee contracts, as allowed in the MSA.
- 9. The Fund Administrator is authorized, upon final distribution of all monies paid into the Fund to eligible Claimants under the terms of the MSA, to take appropriate steps to wind-down the Fund and thereafter the Fund Administrator is discharged from any further responsibility with respect to the Fund.

10.	The Court retains c	continuing jurisdiction and supervision	on over the QSF.
