With respect to the following 36 cases, Plaintiffs has partially completed PFSs, but we are awaiting additional information from the Plaintiffs, signatures on authorizations, and/or are struggling to locate the plaintiff. With respect to these Plaintiffs, we would request an extension until the next scheduled status conference to complete the PFSs and if we are unable to complete them by that time, Plaintiff would agree to their dismissal. We request additional time to complete these PFSs due to some unforeseen consequences related to a long-term tolling agreement entered into between the parties. In November of 2023, the parties entered into a tolling agreement to allow them to negotiate a resolution of Walston, PC's docket. Ultimately, those efforts proved unsuccessful, and 3M terminated that agreement in the spring of 2025, as was their right. At that time, the firm began filing its cases in bulk, which resulted in a large volume of PFSs all being due at the same time. However, in the interim, many of the plaintiffs have moved, phone numbers stopped working, new medical records needed to be obtained, etc. The firm has been diligent working to resolve these issues but requests that the Court allow them to continue that process until the next scheduled status conference for the below cases.
