# DEFENDANTS REGENERON PHARMACEUTICALS, INC. AND SANOFI-AVENTIS U.S. LLC'S STIPULATED JOINT MOTION FOR EXTENSION OF TIME TO FILE A RESPONSIVE PLEADING

Defendants Regeneron Pharmaceuticals, Inc. ("Regeneron") and Sanofi-Aventis U.S. LLC ("Sanofi") (together "Defendants") respectfully move for an extension of time to file a responsive pleading pursuant to Federal Rule of Civil Procedure 6(b) and Local Rule 6.01(a). In support of this Motion, Defendants state the following:

- 1. On October 1, 2025, Plaintiff Chandra Richardson filed her Complaint against Defendants in the Middle District of Tennessee (Doc. No.1).
- 2. Regeneron was served with the Complaint on October 23, 2025 (Doc. No. 10).
- 3. Sanofi was served with the Complaint on October 24, 2025. (Doc. No. 11).
- 4. Pursuant to Federal Rule of Civil Procedure 12(a), Regeneron's responsive pleading is currently due on November 13, 2025, and Sanofi's responsive pleading is currently due on November 14, 2025.

- 5. Defendants request the deadline be extended to January 7, 2026, which is 30 days after the Court's Initial Case Management Conference on December 8, 2025 (Doc. No. 6).
- 6. Plaintiff's 197-paragraph Complaint includes exceptionally detailed and complex allegations and raises equally complex legal issues. The requested extension will allow Defendants sufficient time to investigate the allegations and legal issues presented in the Complaint before drafting a responsive pleading. The extension will also allow Defendants to consider any issues raised during the Initial Case Management Conference. Accordingly, granting this extension will promote efficiency.
- 7. On November 4, 2025, Regeneron's counsel conferred with Plaintiff's counsel, and Plaintiff's counsel has agreed that Regeneron may have until January 7, 2026, to file its responsive pleading.
- 8. On November 7, 2025, Sanofi's counsel conferred with Plaintiff's counsel, and Plaintiff's counsel has agreed that Sanofi may have until January 7, 2026, to file its responsive pleading.
- 9. This request is Defendants' first motion for an extension of time and is made in good faith and not for purposes of delay. Granting this Motion will not cause undue delay of the proceedings or prejudice to the parties.

WHEREFORE, Defendants respectfully request the Court enter an order extending the deadline for Defendants to file a responsive pleading to **January 7, 2026**, and grant such other relief as the Court deems just and proper.
