**PRETRIAL ORDER NO. 2:
ORDER APPOINTING
PLAINTIFFS' LEADERSHIP
COUNSEL**

In Pretrial Order No. 1 (Doc. 2), the Court invited Plaintiffs' counsel to apply for positions for Plaintiffs' leadership in this MDL as well as a suggested structure. - d. Developing and implementing a litigation plan with opposing counsel;

- c. Serving as the primary point of contact between plaintiffs' counsel and Co-Lead Counsel/PEC;

- f. Keeping pro se litigants apprised of litigation progress;

9 law firms.
