1 Lyft writes to update the Court regarding the September 4, 2026 order (Dkt. 386) and Lyft's
 2 related administrative motion (Dkt. 394). Following its August 17, 2026 production, Lyft conferred
 3 with Plaintiffs and conducted a further investigation to answer questions Plaintiffs had posed. By
 4 virtue of that investigation, Lyft identified additional documents that Pretrial Order 11 encompasses
 5 (including a production post-dating August 17), and Lyft is collecting those materials so that it can
 6 provide them to Plaintiffs. Lyft anticipates that it will complete its supplemental production no
 7 later than September 30, 2026.
